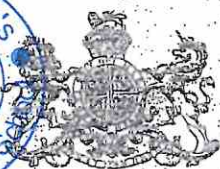

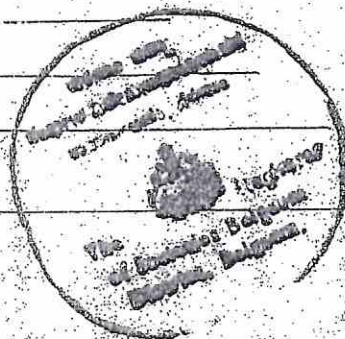

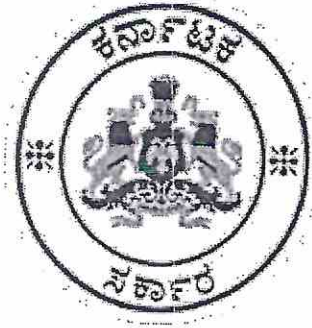

4. This receipt will be cancelled if it is proven that there has been an underpayment of fees due to the government due to false information in the accounts or income and expenditure.
5. If any activities are found to be taking place in the association in a manner that is against the public interest and illegal, action will be taken to cancel the registration of the association under Rule 27(2) of the Karnataka Associations Registration Act, 1960.

Violation of the above conditions will result in cancellation of the association's registration.
