This certificate is issued subject to the following conditions.

- 1 This registration rule subject to 3(5)(4).
- 2 The Governing Council must comply with all the conditions mentioned in rule (4).
3. Owning your own building on your own land within one year.
4. School site, area, building, lessons, furniture, staff, financial advantages, Subject to the condition of providing etc.
5. Under no circumstances may the said educational institution open more departments without the prior permission of the government.
6. The school will be opened only in the approved medium and at the same location and no change of location will be allowed for any reason.
7. The Board to which permission has been granted to run the school shall continue to run it at the same place and under the same name. It shall not be transferred for any reason without the prior permission of the Government.
8. This educational institution shall comply with all government orders and rules in force and issued from time to time in relation to educational institutions and shall strictly comply with the Karnataka Education Act 1983 (Karnataka Act No. 195) and the rules made there under.



9. This Primary School is permanently without aid as per Government Notification No.: ED:175:PMC:95, Date: 7-9-98 and Date: 29-12-98. (Permanently Without-Aid) A consent letter on Rs.10-00 stamped paper certified before a notary stating that the Board does not want any aid from the Government.
10. The rules of the Karnataka Private Educational Institutions (Discipline and Control) Rules, 1999 shall be strictly followed/committed to.
11. Only the textbooks and examination procedures prescribed by the department and the government should be implemented without fail.
12. Within 2 months of obtaining permission, an application for recognition shall be submitted to the competent authorities as per sections 35 to 39 of the Karnataka Education Act, 1983 (Act of 1995) and as per Government Notification ED 131 Misc. 98, Bangalore, dated: 4-11-99 for recognition and provisional recognition as per Government Notification ED 137 Misc. 98, Bangalore, dated: 19-5-99,
13. As per Government Order No.: ED 28 PGC 94, dated: 29-4-94, schools conducting education in Kannada or the mother tongue of the children from class 1 to 5 and following the language policy have been upgraded to English medium from class 6 and registered. If any violation of the language policy is found by the Government/Department/Kannada Development Authority in any of the schools registered under the language policy, the permission and registration of the said school will be cancelled as per the rules. If in any case the documents submitted along with the registration proposal are found to be false, this registration will be cancelled.
14. To start the school, the institution must place the security deposit in a joint account of the Divisional Deputy Director and the Governing Body.
15. The ratio of children to teachers in each class given permission must be followed as per the rules.
16. Only trained and qualified teachers as per the departmental rules shall be appointed.
17. Medical examination of students shall be conducted every year as per the rules.
18. As per the Karnataka Education Bill rules, the facilities required for the school like furniture, teaching aids, library books, playground, school building etc. shall be provided in one category. Otherwise, the registration will be cancelled
19. School work hours and days are being followed as per the department's rules.
20. The opening of the school and the enrolment of students should be reported to this office within two months of the school registration or the commencement of the academic year. If the school is not opened on any of the conditions are not complied with, this order will automatically be cancelled.
21. Since the 6th class (English medium) has been registered for the year 2005-06, the 7th class should be started on the basis of natural growth schools.

4. Under no circumstances may the said educational institution open more departments without the prior permission of the government. :
5. The school shall be opened only in the approved medium and at the same location. We Shall not be allowed to change the location for any reason."
6. The governing body to which permission has been granted to run the school shall run it at the same place and under the same name.
7. This educational institution shall comply with all the Government orders and rules issued from time to time in relation to educational institutions including the provisions of the Karnataka Education Act: 1983 According to the permanent grant-free status, the management board will not raise any grant from the government. The Rs.20 stamp paper a consent letter will be obtained from the Notary.
9. The rules of the Karnataka Private Educational Institutions (Recruitment, Service Conditions and Provisions of Employees of Private Aided Primary and Secondary Education Institutions) Rules, 1999 shall be strictly followed.

10. Only the syllabus and examination procedures prescribed by the department and the government must be followed, shall be implemented.
11. To the Deputy Director concerned for the first accreditation within a period of two months from the commencement of the school.
12. In each class granted permission, the ratio of children to teachers should be as per the rules with an enrollment of 30 and a maximum enrollment in each class should be 25 and a minimum of 60 and attendance should be maintained.
13. Trained and qualified teachers as per the departmental rules shall be appointed.
14. All schools registered under clause 36-30 under Article 8 of the Karnataka Education Act shall come under the ambit of 'Recognition and Provisional Recognition'
15. Medical examination of students should be conducted every year as per your requirement.
16. To start the school, the institution shall keep the security deposit in a joint account of the Divisional Deputy Director and the Governing Body.
17. As per the rules of the Karnataka Education Bill, the school must be provided with facilities like outdoor furniture, teaching aids, library books, playground, school building etc. within one year, failing which the registration will be cancelled.
18. School and work hours and days shall be observed as per the departmental rules.
19. The written order of the Director of the School of student documents school registration or year should be submitted to this office within two months of the commencement of the academic year. If the school is not opened or any of the conditions are not complied with, this order will automatically be cancelled.
20. Since the school is co-educational, it is mandatory to provide separate toilets and drinking water facilities for girls.
21. A service book shall be opened for every teaching/non-teaching staff appointed in the school as per the Karnataka Civil Service Rules and their service details shall be recorded and maintained in it as per the rules.
22. For 8th class, the 'area' has been restricted to the children of their school only.
